Indicative timetable of regular meetings of the Security Council Committee established pursuant to resolution 1540 (2004) for the period from 1 February 2019 to 31 January 2020

I. Background

1. In paragraph 7 of the eighteenth programme of work of the Security Council Committee established pursuant to resolution 1540 (2004) (S/2019/127, annex), and in accordance with paragraph 2 of Security Council resolution 2325 (2016), it was determined that the Committee, with the support of its Group of Experts and the Secretariat, would propose, by the end of February 2019, an indicative timetable of regular meetings in the form of an annex to the programme of work schedule to ensure that its work across all four main areas would be conducted throughout the year in an appropriate and timely manner and that there would be due consideration of and action in the areas agreed upon.

2. Set out below is a provisional and non-exhaustive list of activities and meetings of the Committee and its working groups, which can be amended. The Chair and the Coordinators of the working groups reserve the right to convene additional meetings of the Committee and working groups, as necessary.
