I. In accordance with rule 13 of the rules of procedure, the order in which the above items will be taken up by the Council will form the subject of recommendation by the Agenda Committee for consideration by the Council at its first plenary meeting. The Agenda Committee, consisting of the President of the Council, the first and second Vice-Presidents of the Council, and the representatives of Canada and Poland, is scheduled to meet at Geneva on Tuesday, 27 June 1950.

II. The Secretary-General would be glad to receive as soon as possible after the issue of this provisional agenda any comments or suggestions which Members may wish to make to facilitate the work of the Agenda Committee.

6. Social Defence

(a) It is believed that the studies requested by the Commission (paragraphs 73-76 of Annex IV of E/1678) can be carried out most suitably by consultants. An amount of \$10,000 would be required in 1951, and again in 1952.

(b) For publication of the bulletin on Crime, proposed in paragraph 26 of Annex IV, it would be necessary to establish a post (officer, category G) to carry full responsibility for preparation and editing the bulletin, at a cost of \$8,750 for 1951 and \$9,070 for 1952.

7. Housing and Town and Country Planning (paragraphs 90-95 of Annex IV of E/1678)

(a) The cost of sending any visiting mission of experts to tropical areas in 1951 or 1952 would be met from funds appropriate under Resolution 58(I).

(b) The projects referred to in paragraph 95 of Annex IV are of interest not only to the Social Commission but also to the Economic Commission for Europe. A sum of \$13,688 covering costs of two professional posts and one secretarial-clerical post has been tentatively included in the statement of estimates arising from the annual report of the Economic Commission for Europe - document E/1674/Add.1, para 3. No additional provision for this purpose is included in the statement.

(c) For preparation of the comprehensive report on financing of housing, and the study of housing costs in relation to family income, it would be necessary to enlist the services of one consultant, who would assist the Secretariat in planning the studies. Assuming a total of 10 consultant days, and making allowance for travel costs, the 1951 expenditure would amount to \$760.

8. Social Reference Centre (para 24 of Annex IV of E/1678)

The extension of the present legislative series to cover community and family welfare, social defence and, eventually, other branches of the work of the Commission, would require the addition of one junior officer, category E, at the cost of \$4,250 in 1951 and \$4,500 in 1952.
