## AGREEMENT ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA AND THE REPUBLIC OF THE GAMBIA
