RELATIONS BETWEEN THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI  
LANKA AND THE REPUBLIC OF NICARAGUA


The Democratic Socialist Republic of Sri Lanka and the Republic of Nicaragua, guided by a shared willingness to develop and strengthen the ties of friendship and cooperation between the two countries, have decided to establish diplomatic relations at the level of Non-Resident Ambassadors.

Both parties wish to manifest their confidence in the establishment of diplomatic relations and the exchange of Ambassadors between both countries will contribute to the development of bilateral cooperation and consolidation of world peace.

The Democratic Socialist Republic of Sri Lanka and the Republic of Nicaragua reaffirm their will to build their bilateral relations in accordance with the Charter of the United Nations and International Law, including the principles of peaceful coexistence, equality, mutual respect for the principles of sovereignty, territorial integrity and the non-interference on each other's internal affairs.

Done and signed in New York, on the 15<sup>th</sup> Day of May, Two Thousand and Nineteen (2019), in two originals in the English, and Spanish languages, both being equally authentic.

**COMUNICADO CONJUNTO SOBRE EL ESTABLECIMIENTO DE  
RELACIONES DIPLOMATICAS ENTRE LA REPÚBLICA DE NICARAGUA Y

La República de Nicaragua y la República Democrática Socialista de Sri Lanka, guiados por su disposición de promover y fortalecer las relaciones de amistad y cooperación entre los dos países, han decidido establecer relaciones diplomáticas a nivel de Embajadores No Residentes.
