1. Date and venue

1. The Western Asia Regional Preparatory Meeting for the Thirteenth United Nations Congress on Crime Prevention and Criminal Justice will be held in Doha, from 3 to 5 February 2014. 

8. Participants are required to make their own transportation arrangements to and from the airport upon arrival and departure. The Sharq Village and Spa Hotel will, upon request, arrange transportation between the hotel and the airport.

9. Foreign exchange

- 11. The currency of Qatar is the riyal (QR), which is fixed to the United States dollar at the rate of \$1 = QR 3.64. There are 100 dirhams to the riyal. Notes are in denominations of QR 500, 100, 50, 10, 5 and 1. Coins are in denominations of 50, 25, 10, 5 and 1 dirhams, of which, only the 50 and 25 dirham coins are in wide circulation; minting of the rest ceased in the 1970s and the smaller denomination coins are becoming ever scarcer.
- 12. Major credit cards (Visa, MasterCard, American Express, Diners Club) and traveller's cheques in principal currencies are generally accepted in large hotels, restaurants, department stores and several other large shops. Traveller's cheques and bank notes in all major currencies may be exchanged at all commercial banks and most hotels and foreign exchange counters. ATM services are also available.

10. Climate

13. The month of February is characterized by a daily high temperature that increases from 22°C to 25°C over the course of the month, exceeding 28°C or dropping below 19°C only on one day in 10.
