

Letter dated 17 June 2019 from the Chargé d'affaires a.i. of the Permanent Mission of Libya to the United Nations addressed to the President of the Security Council

Annex to the letter dated 17 June 2019 from the Chargé d'affaires a.i. of the Permanent Mission of Libya to the United Nations addressed to the President of the Security Council

President Serraj Initiative 17-6-2019

- 1. To hold a Libyan Forum in coordination with the United Nations Mission, which will be comprised of representatives of all national actors, and all components of Libyan society, who have political and social influence, and who call for a peaceful and democratic solution, and advocate for the rights of citizenship, and call for the building of a civil state, a state of institutions and under the rule of law.
- 2. In this Forum a roadmap should be agreed upon for the upcoming period, and for the establishment of a proper constitutional foundation, in order to hold simultaneous presidential and parliamentary elections before the end of 2019. A specialized Legal Committee will then be appointed by the Forum to draft necessary laws stipulating what was agreed upon.
- 3. The Forum shall then adopt the laws concerning the constitutional and electoral process submitted by the Legal Committee, which will specify the dates of elections and all other commitments, and will refer it to the High National Electoral Commission.
- 4. The Forum will call upon the UN Security Council and the international community to support this agreement, which should be binding to all parties. The United Nations will be responsible for organizing and overseeing the electoral process and its related commitments. The Forum will also call upon the African Union and the European Union to provide the necessary support for its success.
- 5. Committees will be established under the supervision of the United Nations, comprised of the current executive and security institutions in all regions, whom will ensure the availability of resources in order to fulfil the electoral process, including the security arrangements necessary for its successful implementation.
- 6. The Forum will agree upon the mechanisms for administrative decentralization, the optimal use of financial resources, and a fair and comprehensive economic development plan for all regions in Libya, while ensuring transparency and good governance.
- 7. A Supreme Council for National Reconciliation emerges from this Forum, which supervises and monitors national reconciliation, and creates a mechanism for activating the transitional justice law, and amnesty and reparation law, with the exception of those who committed war crimes and crimes against humanity.
