Statement submitted by International Multiracial Shared Cultural Organization, a non-governmental organization in consultative status with the Economic and Social Council*

Statement

Imagine you arrive to your home to find thieves in your living room sitting on your sofa selling off your furniture and demand you to assist them as they deliver it to the buyer. As if that wasn't enough, they assess a tax to you on your furniture that they sold. This illegal access to Africa's land and property, statehood and banning people of African Descent is a fraud.

IMSCO empowers Africans and Africans in the diaspora to trade and do business to increase our economic power. IMSCO, provides guidance for Africans to manage their Trillions of dollars annually – in the form of gold 54%, and 85% of world's supply of platinum; 89% of the world's diamond when combined with the Russian Federation; Chromium 99%; Colton 80% of the world's supply just to name a few assets we work to include Africans in the billions of dollar deals that Africans are excluded from by multinational corporations.

For the past 40 years, IMSCO has had boots on the ground in Africa, we are proud to share with you here today that one of our greatest achievements is the "IMSCO Establishment Agreements" has been signed by African countries. Through these agreements, IMSCO has the authority to redistribute, broker, and empower People of African Descent to conduct and do business with the African countries. IMSCO empowers People of African descent to repatriate to the participating countries. Thereby, bringing knowledge, families, and needed resources back to the continent to assist with building infrastructure in these states. Furthermore, IMSCO empowers youth and women of the continent through entrepreneurship programs, and budgeting assistance.

In conclusion, for the next decade we plan to ensure inclusions of Africans and People of African Descent by reuniting families, extending lines of credit for education and entrepreneurship. The lines of credit will include Africans and People of African Descent in knowledge acquisition at the Universities to which they are accepted to support our effort to develop human capital. To spur economic growth, IMSCO plans to extend lines of credit to businesses to increase investment spending, production and job creation, thereby, increasing trade and economic growth among African states. This will lead to an increase in personal and corporate tax revenue and an increase in the GDP.

Our organization wants to collaborate with PAD and NGOs on the African continent that work to build infrastructures, international policy, or that work in the market for energy. For all African leaders, Ambassadors, and Heads of State, equality occurs when Africans and Africans in the Diaspora share our wealth, do business with each other, and the world without colonial influence. We want to sign Establishment Agreements across the continent During the Decade of People of African Descent, which ends in 2024, to ensure that Africans and Africans in the Diaspora are prospering from all the deals that occur on our homeland.
