

**JOINT COMMUNIQUE ON THE
ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN THE PLURINATIONAL STATE OF BOLIVIA AND
THE REPUBLIC OF MALDIVES**

The Plurinational State of Bolivia and the Republic of Maldives, guide by a shared willingness to develop and strengthen the ties of friendship and cooperation between the two countries, have decided to establish diplomatic relations at the level of Ambassadors.


Both parties wish to manifest their confidence that the establishment of diplomatic relations and the exchange of Ambassadors between both countries will contribute to the development of bilateral cooperation and the consolidation of world peace.

The Plurinational State of Bolivia and the Republic of Maldives reaffirm their will to build their bilateral relationship in accordance with the Charter of the United Nations and international law, including the principles of peaceful coexistence, equality and mutual respect for sovereignty of each other's territory, and the non-interference in each other's internal affairs.

The undersigned, duly authorized by their respective Governments, sign the present Joint Declaration in duplicate, in English and Spanish, both texts being equally authentic.

Signed in New York, on the 31th day of May in the year 2019.





COMUNICADO CONJUNTO SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMÁTICAS ENTRE LA REPÚBLICA DE MALDIVAS Y LA EL ESTADO PLURINACIONAL DE BOLIVIA

La República de Maldivas y la El Estado Plurinacional de Bolivia, guiados por la voluntad de desarrollar y fortalecer los lazos de amistad y cooperación entre los dos países, han decidido establecer relaciones diplomáticas a nivel de Embajadores.

Ambas partes desean manifestar su confianza en que el establecimiento de relaciones diplomáticas contribuirá al desarrollo de la cooperación bilateral y la consolidación de la paz mundial.

La República de Maldivas y la El Estado Plurinacional de Bolivia reafirman su voluntad de forjar una relación bilateral de conformidad con la Carta de las Naciones Unidas y el derecho internacional, incluidos los principios de coexistencia pacífica, igualdad y respeto mutuo de la soberanía territorial, y la no injerencia en los asuntos internos.

Los suscritos debidamente autorizados por sus respectivos gobiernos, firman la presente Declaración Conjunta por duplicado, en inglés y español, siendo ambos textos igualmente idénticos.
