

**JOINT COMMUNIQUE**  
**ON ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE**  
**REPUBLIC OF**  
**UGANDA AND THE REPUBLIC OF NICARAGUA**



The Government of the Republic of Uganda and the Government of the Republic of Nicaragua,

Desirous to promote and strengthen friendship and cooperation between their countries on the basis of equality, peaceful coexistence, mutual respect for each other's sovereignty, independence and territorial integrity as well as non-interference in the internal affairs of each other;

Guided by the principles and purposes of the Charter of the United Nations, as well as the Vienna Convention on Diplomatic Relations of 1961 and Vienna Convention on Consular Relations of 1963;

Have agreed to establish diplomatic relations, as of the date of signature of this Joint Communique.

In witness thereof, the undersigned Permanent Representatives, duly authorized by their respective Governments, have signed this Joint Communique in duplicate, Spanish and English languages, all texts being equally authentic.


