**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN THE REPUBLIC OF CABO VERDE AND THE
COMMONWEALTH OF DOMINICA**

The Government of the Republic of Cabo Verde and the Government of the Commonwealth of Dominica:

Desirous of promoting mutual understanding and strengthening the friendship and cooperation between the two countries,

Guided by the principles and purposes of the Charter of the United Nations and international law, particularly on the respect for the promotion of international peace and security, equality among States, national sovereignty, independence, international treaties, territorial integrity and non-interference in the internal affairs of other States,

Have decided to establish diplomatic relations, as of the date of signing of this Joint Communiqué.

Intended that their diplomatic relations are based on the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961,

In witness thereof, their Excellencies, Ambassadors Extraordinary and Plenipotentiary, duly authorized by their respective Governments have signed this Joint Communiqué in English, Portuguese and English the two texts being equally authentic,
