FURTHER TO MY TELEGRAM OF 8 AND MY LETTER OF 17 JULY 1951 DEEPLY REGRET INFORM YOU THAT LOCAL ADMINISTRATION PURSUING I'DS POURTY OF SUPPRESSING ANY AUTONOMIST AND NATIONALIST MOVEMENT ORDERED FOLICE TO FIRE ON DEMONSTRATORS AT VILLAGE OF VOGAN IN THE CERCLE OF ATTUCO EXTLENG TWO WOMEN AND SEVEN MEN ON THE SPOT AND WOUNDING SEVERAL OFFICES NOT IT! COUNTED STOP REASON FOR THIS BRUTAL AND INHUMAN SUPPRESSION IS DISPUTE CONCERNITY SUCCESSION TO OFFICE OF CHIEF WHICH HAS RECENTLY BECOME VACAPE OWING TO DEATH OF CHIEF KALIPE STOP LARGE MAJORITY OF VILLAGE DEMAND IN ACCORDANCE WITH OUR CUSTOM APPOINTMENT OF FO ADVISOR OF DECEASED CHIEF AS RETAINS DUPING FULTIAL PERIOD MIEREAS ADMINISTRATION SUPPORTS ITS OWN CANDIDATE AS IMPEDIATE SECCESSOR STOP AS SITUATION VERY SERIOUS AND SIMILAR CASES AT ISSUE IN OTHER CEPCIES BET YOU TO DRAW ATTEMPTON OF GENERAL ASSEMBLY IMMEDIATELY TO THE MATTER SO THAT IT MAY ORDER AN INQUIRY TO ESTABLISH RESPONSIBILITY STOP WITH THANKS RESPECTE JLLY
