JOINT COMMUNIQUÉ  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN  
REPUBLIC OF PALAU  
AND  
PEOPLE'S REPUBLIC OF BANGLADESH

*The Republic of Palau and the People's Republic of Bangladesh,*

Guided by mutual willingness to develop friendly, peace and cooperative relations in diplomatic, political, economic, humanitarian and other fields,

Convinced that the establishment of diplomatic relations corresponds to the interest of both States and will further strengthen international peace and security,

In accordance with principles and purpose of the United Nations Charter and the provisions of the Vienna Convention on Diplomatic Relations of 18<sup>th</sup> April 1961;

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed this Joint Communique, New York on 16<sup>th</sup> July 2019, in duplicate.

This agreement shall come into force upon the date of last notification by both states of the completion of their internal procedures necessary for its entry into force, as appropriate.
