## PETITION FROM MR. VICTOR EOAIO CONCERNING NAURU

(Circulated in accordance with rule 85 and supplementary rule D of the rules of procedure for the Trusteeship Council)

Note by the Secretariat: This communication was transmitted to the Secretary-General by the United Nations Visiting Mission to Trust Territories in the Pacific.

The Chairman, 1956 Visiting Mission, Territory Trusteeship Council.

Dear Sir,

I beg leave to submit few matters relating to my work in Nauru Administration Hospital as a Laboratory Technician.

I join the medical service in the year 1940 as Medical Orderly and after several years later, after the war in 1946, I was transferred to the Pathology section until 1954 when the Nauru Administration arranged my training somewhere outside the Territory. I was, afterward, sent to Australia for six months training on some certain courses on Laboratory technique in a School of Public Health and Tropical Medicine, Sydney.

After completion of six months training in the above School, I returned to the island and take up a position in the same Hospital and I was then classified as Laboratory Technician, and second man in position to the Mauruan Pathologist.



I had lodged a several petitions to Nauru Administration through the Government Medical Officer on the revision of my margin of skill in comparison with other Nauruan who have a better margins but they are not had once been trained or underwent any courses for their trade or profession.

I think, perhaps, it would be useful and helpful enough to note down for you the following duties which I have performed and part responsible at present:-

- 1. Bacteriology.

  (a) Examination of Faeces.

  (b) " " Sputum.

  (c) " " Blood

  (d) and some others.
- 2. Chemistry and
  Biochemistry. (a) Examination of blood. (Some of it)
  (b) " " CSF. (Some of it)
  (c) Urinalysis
- 3. Histo-Pathology.

Preparation of Sections for study and diagnosis.

- (a) Biopsy Leprosy tissue etc.
- (b) Autopsy When required.
- 4. <u>Haematology</u>. (a) Red and white cells count.
  - (b) Differential count.
  - (c) Haemoglobin estimation.
  - (d) Some others.
- 5. Parasitology. (a) Examinations of blood. (some of it) (b) "faeces (some of it)
- 6. Looking after the equipment, apparatus etc.
- 7. Take charge of the Pathology Department during the absent of Nauruan Pathologist.

In regard to last duty (7), I had, on few occasions, carried on the duty of looking after the works and place during pathologist's absent for two months while he was in Australia with other Administration's Officials in connexion with the Queen's visit and his absent on period of recreational leave or sick leave.

I would be very pleased, if the mission could advise me on the matter that I am receiving an adequate scale on my present margin.

Nauruan pathologist is based on a minimum margin of more than £200. and maximum of less than £400 and some trade workers of the Administration are basing on a better margin whereas I am on the maximum margin of £120.

Unfortunately, the establishment for Nauruan employees has been entirely established and I would therefore ask the mission to find its way and see if it could be revised.

Hoping the petition would be favourably considered by the Mission.
