**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN
THE REPUBLIC OF KENYA AND THE REPUBLIC OF TAJIKISTAN**

With the purpose to promote mutual understanding and to strengthen the friendship and cooperation among their two peoples,

On the basis of International Law, in particular the purposes and principles of the Charter of the United Nations relating to the promotion of international peace and security, the respect of national sovereignty, equality among States, independence, territorial integrity, international treaties and non-interference in the internal affairs of States,

Have decided to establish Diplomatic Relations at the Ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, as of the signing of this Joint Communiqué.

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed in duplicate this Joint Communiqué in English and Tajik languages, both texts being equally authentic, in New York.
