I the undersigned Abdi Adan Nur, tribe Issak, aged 26 yrs. born in Afgoi, humbly and respectfully have the honour to state as follows:

Recently, I applied to gain a driving license which will enable me to drive trading Vehicles. I paid So.100/- to an Italian Sig. Piazzardi, through whom all candidates gain their license, because no drive passes his test unless produced by the said Italian who claims to be the owner of guiding School. In additions of the said So.100/-, I spend the following:

After having spent all these and before I undergone any test, I was informed that I won't gain any licence because I had previous conviction of 4 months imprisonment. I informed them that I was minor of age, and since. I growned to present age, I committed no further offences, but they failed to take in considerations. It is entirely unfair to be deprived of any job for a small act that happened when I was child, an I have to maintain my old father who is blind, old mother, and 5 young brothers who own no property.

In the other hand they made me to spend without doing anything for me. If I am unable to gain any job for the sack of the minor previous conviction, that happened long time ago, now, then where I am expected to gain any job?

I claimed the repayment of my hundred Somali, and had contacted the pubblico ministro, District Commissione, Civil Office and all Police Station, but no act was taken against the Italian, against whom I protested.

Therefore, I shall be very highly obliged if you will be so kind enough as to grant me your legal aid regarding my case.

For doing this favour, I shall ever remain grateful and pray almighty God to long your life and prosperity.
