## PETITION FROM THREE REPRESENTATIVES OF THE WALAMON CONCERNING SCHALTLAND UNDER TTALTAN ADMINISTRAT

Note by the Secretary-General: In accordance with rule 30 and supplementary rules F and L of the rules of procedure for the Trusteeship Council, the Secretary-General has the honour to transmit to the members of the Trusteeship Council, to the Government of Italy as the Administering Authority of the Trust Territory of Schaliland, and to the Governments of Colombia, Egypt, and the Philippines as members of the Advisory Council for the Trust Territory of Schaliland, a communication dated 2 May 1952 from three Representatives of the Walamoy tribe concerning the Trust Territory of Schaliland under Italian administration.

This communication was transmitted to the Secretary-General by the United Nations Advisory Council for the Trust Territory of Somaliland under Italian administration.

We the undersigned ISIAO DASHO; HILOWIE GULED and MAHAMOUD ABGALOW, on behalf of the Walamoy tribe residing in the tribes 12 villages of Bulo Ahmed, Sabun, Murialeh, Lama Wab, Magadley, Gafai, Bur Bisharo, Gheda Berkan, Timirè, Giohar, Balguri and Bayahow (district of Villabruzzi), have the honour to bring to your kind notice what follows:-

The tribes of the Walamoy have come to understand that YUSUF AHMED of the village of Sabun, ISLAO MUSSE MCHAMED of Bayahow and ABDULIAHI MALLIM of Bur Bisharo (who were amongst the ten persons who have submitted a petition on behalf of the Walamoy tribe to the U. N. Advisory Council on 22nd February 1952) were influenced and corrupted by the local Resident Dr. Tripiciano, who made them sign documents in favour to the S.A.I.S., on the night of 30th April 1952 and at the Resident's house.

The undersigned representatives have been instructed to draw your kind attention to the fact that whatsoever and any document cigned by the above named persons (i.e. Yusuf Ahmed, Islao Mussa Mohamed and Abdullahi Mallim) in regard to the Walamoy tribe and the tribes' legitimate land property is null and void. Such documents are intended, we believe, to subvert the true nature of the claims on our land made against the S.A.I.S., and therefore these documents have nothing to do with the Walamoy tribe, but shall be pertinent only to the above named persons.

The Walamoy tribe hope that the U.N. Advisory Council will understand the nature and intend of the Resident's policy in connection to their legitimate property. Needless to say that Dr. Tripiciano stated in public that the U.N.

cannot do anything and that he is the only person that has power on the villages of the Walamoy tribe. Despite this affirmation, we have much faith in the United Nations and firmly believe that our land will not be misappropriated by the SAIS or the Administration itself in the eyes of the U.N. Advisory Council.

In view of the above circumstances, we ask the U.N. Advisory Council to include in its report this year to the Trusteeship Council all petitions of claims that were submitted by the Walamoy tribe.

We are confident that this letter of ours shall meet with your favourable consideration, and while avaiting an early reply, we thank you very much in savance.
