

## TRUSTEESHIP COUNCIL



PETITION FROM CHIEFS AND REPRESENTATIVES OF THE CABILA REA MOHAMUD TRIBES AND SIX OTHER TRIBES CONCERVING SOMALILAND UNDER ITALIAN ADMINISTRATION

Note by the Secretary-General: In accordance with rule 85 and supplementary rules F and L of the rules of procedure for the Trusteeship Council, the Secretary-General has the honour to transmit to the members of the Trusteeship Council, to the Government of Italy as the Administering Authority of the Trust Territory of Somaliland, and to the Governments of Colombia, Egypt, and the Philippines as members of the Advisory Council for the Trust Territory of Somaliland, a communication dated 3 April 1952 from Chiefs and Representatives of the Cabila Rer Mohamud Tribes and six other Tribes, concerning the Trust Territory of Somaliland under Italian administration.

This communication was transmitted to the Secretary-General by the United Nations Advisory Council for the Trust Territory of Somaliland under Italian administration.

Subject: VIGOROUS PROTEST AGAINST DAHIR SED AND ISMAIL GIAMA GIS REPRESENTATION AT THE TERRITORIAL COUNCIL AS MUDUGH REPRESENTATIVE FOR THE YEAR OF 1952

We the undersigned Chiefs, Notables, Sceiks and dignitaries of Cabila Rer Mohamud Tribes respectfully beg to bring to your August attention our vigorous protest against Mrs. Dahir Sed Giama and Ismail Giama Gis representation at the Territorial Council as Mudugh Province's representatives for the following reasons:

- Mrs. Dahir and Ismail, who were the Secretary and Vice Secretary of the namely existing "Lega Progressista Somala" party since the return of the Italian Administration to Somalia i.e. when this party was founded, had been nominated by the Local Authority, without being fairly elected by the inhabitants of this circumscription.
- Certainly, the so-colled "Lega Progressista Somala" party to which these two "Lionized" fellows belong is, in fact, existing by name in this province. The Trusteeship Council's Visiting Mission, who visited Galcaio Sometimes in the Last Year of 1951 and, the Advisory Council's Visiting Mission, who Visited this Province sometimes in February, 1952 can, if necessary, impartially testify, accordingly.
- Educationally, our brothers, Mrs. Dahir and Ismail are absolutely illiterate, who, without being unjustly discredited, can not neither write nor read properly in any language. This is a violation of an Article of the Council regulations contents of which we are unfortunately unable to portray therein due to unavailability of it, but, however, read that the Councillors should write and read properly in one of the languages usefully existing in the Territory, particularly English, Arabic or Italian.

- 4, Additionally, neither Mr. Dahir nor Mr. Ismail is chief of a Tribe nor, even, popular by his own tribe, but, contrarily, because of being direttive members of namely existing party, which is categorically "pro Italian", they were so nominated by the Administration in order to betray their lovely motherland to its worst enemy for personal interest.
- Many protests were intensively manifested by the inhabitants concerned against such a "gerrymander" but, unfortunately, no consideration was apathetical contemplated, whatsoever, on the part of the Administration,
- Nevertheless, reading with keen interest of the expressions and opinions given by each of the councillors on the matters discussed to date in the Council, expressions and opinions which had been published in the Local paper (Corriere della Somalia), we found it out that, all that expressed and opinionated by Mrs. Dahir and Ismail were absolutely of innovendo, petty and spurious struggles for which end they were, of course, constituted.
- In short, we would emphatically like to make it clear that, Mrs. Dahir and Ismail are under no circumstance representing at that Council in the name for any form or guise.

In conclusion, your consideration on this important protest is greatly appreciated with many thanks in anticipation.
