

The Russian representative office of the Russian and Turkish Joint Commission reviewing issues related to violations of the ceasefire regime has reported 27 incidents of gunfire in the following Governorates: 8 in Aleppo, 8 in Ladhiqiyah, 6 in Hama and 5 in Idlib.

The Turkish representative office has reported 12 incidents of gunfire in the following Governorates: 7 in Idlib, 3 in Hama, 1 in Aleppo and 1 in Ladhiqiyah.

The Centre for Reconciliation of Opposing Sides and Refugee Migration Monitoring has not carried out any humanitarian operations over the past 24 hours.
