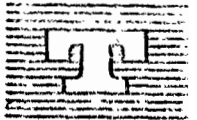

AND FARHANO DISTRICTS SITUATION UNCHANGED AND EVEN WORSE STOP YESTERDAY IN THE
PRESENCE OF DISTRICT COMMISSIONER AND "BRIGADIERE" AT FARHANO SEVERAL OF OUR
MEMBERS WERE THREATENED WITH DAGGERS AND CLUBS WITHOUT INTERFERENCE FROM
AUTHORITIES PRESENT STOP LOCAL AUTHORITIES ATTITUDE LEADS TO BELIEF THAT THEY
