PETITION FROM UGAZ NUR OF THE AVERGHIDIR TRIBE, AND OTHERS
CONCERNING SOMALILAND UNDER ITALIAN ADMINISTRATION

Note by the Secretary-General: In accordance with rule 85 and supplementary rules F and L of the rules of procedure for the Trusteeship Council, the Secretary-General has the honour to transmit to the members of the Trusteeship Council, to the Government of Italy as the Administering Authority of the Trust Territory of Somaliland, and to the Governments of Colombia, Egypt and the Philippines as members of the Advisory Council for the Trust Territory of Somaliland, a cable dated 20 July 1952 from Ugaz Nur of the Averghidir Tribe, and others, concerning the Trust Territory of Somaliland under Italian administration.

IN THE NAME OF ALL OUR PEOPLE AND OF THE TOWN OF EL BUR WE REQUEST THAT DOCTOR MUNGIOLI BE IMMEDIATELY REPLACED BECAUSE HE DOES NOT DO HIS DUTIES WELL, BECAUSE HE SWEARS AT OUR PEOPLE AND HE REFUSES TO CARE FOR PERSONS SERIOUSLY ILL, THEN DOCTOR MUNGIOLI HAS AN UGLY ILLNESS AND ACCORDING TO OUR LAW (SCIARAHIA) HE MUST NOT APPROACH OTHER PEOPLE. WE REQUEST THAT HE BE REPLACED IMMEDIATELY AND IF THE ADMINISTRATION DOES NOT HAVE ANOTHER ITALIAN DOCTOR TO SEND WE ARE ALL QUITE READY HERE TO BE TAKEN CARE OF EVEN BY A GOOD SOMALI DRESSER OF WHOM THERE ARE MANY. GREETINGS.
