PETITION FROM MR. ADEN MOHAMED JAMA CONCERNING SCMALILAND UNDER ITALIAN ADMINISTRATION

(Circulated in accordance with rule 85 and supplementary rules F and L of the rules of procedure for the Trusteeship Council)

Note by the Secretariat: This communication was transmitted to the Secretary-General by the United Nations Advisory Council for the Trust Territory of Somaliland under Italian Administration.

To: The Advisory Council of the United Nations Mogadiscio

I was a private in the AFIS "Polizia Tributaria" (Fiscal Police) posted in Mogadiscio. I was dismissed from service without justifiable reason, and was denied the right to a gratuity as well as to overpay of "fiammo" (?) for two months and three days, at the rate of So. 30 per month. To my protest and request for justice dated 12 August 1953, the AFIS Department of Financial Affairs, in letter no. 141381 signed by the Administrator, replied charging that I fell asleep while on duty, which is not true.

I therefore apply to you, begging you to intervene and take up the matter with a view to settle this matter, as I am certain, from reliable information received, that I was discharged from service because elements hostile to me had reported to the Command of the "Guardia di Finanza" that I was suspected of harbouring "nationalist ideas" and of being "pro-Somali", whereas I have no political tendencies of any sort.

I am strongly confident in your comprehension and impartiality with regard to the foregoing.

I dutifully thank you and tender my best regards.

Mogadiscio, 12 August 1953

To: AFIS, Department of Financial Affairs

The undersigned, ADAN MOHAMED JAMA, Tribe Averghidir Aer, living in Hamar Wen Village, Mogadiscio, has the honour to point out that he had submitted an application for enlistment in the "Polizia Tributaria" as apprentice-private. Three months later he was invited to pass the examination, and having passed it successfully, the Command instructed him to put on the uniform, and on the same day he was ordered to take it off; however, he was told that from that day onwards he formed part of the "Polizia Tributaria" and he was not to forget it. Two months later he was summoned by the Command and ordered to put on the uniform again, after taking a driver's test. He was then tested as a motorcyclist and passed another test as driver. Tests having been successful, he was told that he was to spend three months as apprentice, after which he would become a private in the Fiscal Police.

Instead of three months, the undersigned spent five months as an apprentice. In the fifth month he felt unwell one evening and reported to the Brigade Commanding Officer, who told him that he was detailed for orderly duty starting from 6 p.m. During the night, at 3 a.m., the Commanding Officer came and said that he had fallen asleep while on duty. The undersigned replied that he had never fallen asleep, but thirteen days later when collecting his pay, found that he had been punished with ten days' half pay, though no one asked whether it was true that he had fallen asleep. In the sixth month the undersigned was given the badge of the Corps, and three days later he was told to take off his uniform because he was discharged.

Having asked the reason for his discharge he was told that it was because he had fallen asleep. When he asked pay for the three days he had worn the badge he was asked who gave him the badge. The undersigned replied that it was the Command. The undersigned is not guilty of any fault, and deems it unjust to be discharged after he had devoted himself to service.

Therefore, the undersigned has the honour to submit a respectful request to be re-enlisted, because he is not guilty of the fault he was charged with.
