The Government of the Republic of Rwanda and the Government of the Republic of Ecuador,

Desirous of promoting mutual understanding and strengthening the friendship and cooperation between the countries;

Guided by the principles and purposes enshrined in the Charter of the United Nations and the principles of international law, particularly respect for promotion of international peace and security, State sovereignty, equality among States, independence, international treaties, territorial integrity, and non-interference in the internal affairs of other States;

Have decided to establish diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, the Vienna Convention on Consular Relations of 24 April 1963, and based on the principles enshrined in the Charter of the United Nations, as of the date of signing of this Joint Communiqué;

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed this Joint Communiqué, in duplicate, in the English languages, all texts being equally authentic.


