**JOINT COMMUNIQUÉ  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN  
THE REPUBLIC OF TAJIKISTAN AND BARBADOS**

The Republic of Tajikistan and Barbados,

With the purpose to promote mutual understanding and to strengthen the friendship and cooperation among their two peoples,

On the basis of the International Law in particular, the purposes and principles of the Charter of the United Nations relating the promotion of the international peace and security, the respect of national sovereignty, equality among States, independence, territorial integrity, international treaties and non-interference in the internal affairs of States,

Have decided to establish diplomatic relations at ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of the signing of this Joint Communiqué.

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed in duplicate this Joint Communiqué in New York, on 8 November 2019, in two originals, in English and Tajik languages.

Бо боварӣ бар ин ки барқарории муносибатҳои дипломатӣ ҷавобгӯйи манфиатҳои ҳар ду кишвар буда, ба таҳқими минбаъдаи сулҳу амнияти ҷаҳонӣ мусоидат ҳоҳад кард,

Қарор доданд, ки робитаҳои дипломатиро аз таърихи ба имзо расидани Баёнияи муштараки мазкур барқарор намоянд;
