Letter dated 26 March 1979 from the Permanent Representative of Jordan to the United Nations addressed to the Secretary-General

#### ANNEX I

# Text of a message dated 21 December 1978 received from Mariam Al-Shakhshir

General Directorate for Prisons

Sender's name: Mariam Al-Shakhshir Concentration camp of: Al-Ramleh

I wish to bring the following facts to your attention. We have three fellow female prisoners here who have been sentenced to life imprisonment. They have already spent ten years in prison and are seriously ill. One of them, Aysha Oda suffers from heart disease, gastric ulcers, pains in the kidneys, headaches, rheumatism and other diseases. The second one, Ayda Saad, suffers from pneumonia and her sputum is mixed with blood. The third prisoner is Afifah Bannoura, who suffers from rheumatism which has affected her heart and the small arteries in her legs.

As the continuation of this situation means death for these three fellow prisoners, I beg you to save them. We are all hopeful that you will take speedy and ample steps in this regard.
