**Land violations committed in October 2019**

1 October	0800	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0845 hours.
	1435	Inside occupied Palestinian territory, opposite the town of Alma al-Sha'b, two Israeli enemy soldiers pointed their firearms at a patrol of the United Nations Interim Force in Lebanon (UNIFIL). The patrol left in the direction of occupied territory at 1441 hours.
2 October	0750	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannons of two Merkava tanks towards Lebanese territory. The tanks left in the direction of occupied territory at 0830 hours.
	1920	Israeli enemy soldiers inside the position of Shaykh Abbad threw firecrackers at two Lebanese civilians on the outskirts of the town of Hula, without causing injuries.
3 October	0800	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0835 hours.
4 October	–	The Israeli enemy laid barbed wire to the south of the concrete blocks at the entrance to the gate leading to the occupied Shab'a Farms, in the locality of Bastrah on the outskirts of Kafr Shuba town, in occupied Lebanese territory.
	0800	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0850 hours.
5 October	2200	Opposite the town of Udaysah, the Israeli enemy directed a searchlight mounted on a Humvee vehicle towards Lebanese territory.
6 October	1250	At Ra's al-Naqrarah, in occupied Lebanese territory, two Israeli enemy soldiers in military uniform and one in civilian clothing carried out maintenance work in the control room of the cameras mounted on the tower south of point M1. At 1450 hours, work ended and the soldiers returned into occupied territory.

7 October	0750	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0845 hours.
	1430	A four-person Israeli enemy foot patrol attempted to abduct the herder Mahir Hamdan, who was tending to livestock in the locality of Saddanah, on the outskirts of Shab'a, near observation point OP3 operated by the Indian contingent of UNIFIL, opposite Birkat al-Naqqar. He succeeded in fleeing towards the town with his livestock.
8 October	0750	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0845 hours.
9 October	0900	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 1045 hours.
10 October	0750	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0930 hours.
	1000	An Israeli enemy patrol comprising two Hummer vehicles, one of which was equipped with a machine gun, approached from inside occupied Palestinian territory near Barad al-Tuffah, opposite Sahl al-Khiyam. A patrol member pointed the machine gun towards Lebanese territory. The patrol left in the direction of occupied territory at 1100 hours.
	1145	While the deputy chief of the liaison unit and a topographical team comprising members of UNIFIL and of the Lebanese Army were taking measurements near the locality of Ra's al-Naqurah with a view to marking the precise location of the wall blocking the railway tunnel, five Israeli enemy soldiers crossed the Blue Line by a distance of some 30 metres east of point B1 and took up positions behind the technical fence, on occupied Lebanese territory. The patrol left in the direction of occupied territory at 1310 hours.
	1150	In Ra's al-Naqurah, at point B1, five Israeli enemy soldiers crossed the Blue Line and observed the activities of the topographical team comprised of Lebanese Army and UNIFIL personnel.
	1200	Inside Lebanese territory in Yarun, near post 6-50 belonging to the Irish UNIFIL contingent, two teams from the Chinese and Cambodian engineering contingents detonated 40 landmines left behind by the Israeli enemy. Work ended at 1300 hours.

	2040 2115	From inside the occupied Shab'a Farms, the Israeli enemy launched six flares over Jabal al-Shahl for unknown reasons.
11 October	0750	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0900 hours.
	1620	While the herder Isma'il Zahrah was tending to his livestock in the locality of Bastrah on the outskirts of Kafr Shuba, at the entrance to the Shab'a Farms gate, an Israeli enemy patrol approached from inside occupied territory, without crossing the line of withdrawal, and fired several rounds of gunfire towards the herder and his livestock. The herder fled towards the town of Kafr Shuba and nobody was harmed. The patrol left in the direction of occupied territory at 1650 hours.
13 October	0800	From inside the Shab'a Farms, at the hostile position in Ruwaysat al-Alam, Israeli enemy soldiers pointed a Merkava tank cannon in the direction of a Lebanese Army observation point. The tank left in the direction of occupied territory at 0830 hours.
14 October	0900	An Israeli enemy patrol comprising two Hummer vehicles, each of which was equipped with a machine gun, approached from inside occupied Palestinian territory near Barad al-Tuffah, opposite Sahl al-Khiyam. Patrol members pointed the machine guns towards Lebanese territory. The patrol left in the direction of occupied territory at 0930 hours.
15 October	0753	Inside occupied Palestinian territory, opposite the town of Udaysah near point TP36, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0830 hours.
	0800	Inside occupied Lebanese territory, opposite the town of Wazzani, the Israeli enemy installed 24 concrete T-wall units around its position in Humayri using a trench digger, a wheeled bulldozer, a winch and a civilian pickup truck. They also installed two cameras near the work site. Members of the patrol trained their weapons on Lebanese territory for five minutes. Work ended at 1715 hours.
16 October	0930	Inside occupied Lebanese territory opposite the town of Wazzani, the Israeli enemy continued with the engineering work that had begun on 15 October, installing 14 concrete T-wall units around its position in Humayri using a winch, a wheeled bulldozer, a Poclair excavator, a Bobcat vehicle, a truck, a civilian pickup truck, seven labourers and seven guards. An Israeli enemy soldier trained his weapon on Lebanese territory for 30 seconds. Work ended at 1600 hours, and all the soldiers and vehicles left in the direction of occupied territory.
	0926	The Israeli enemy launched a flare near the town of Shab'a. Separately, a trip flare exploded. It had been planted by means of a steel peg in the ground, which was connected to a cable affixed to an oak tree and camouflaged with brush.

	0930	A percussion bomb exploded while the civilian Mahir Hamdan was tending to his livestock near the withdrawal line in the locality of Jabal al-Saddanah, on the outskirts of the town of Shab'a, near observation point OP3 operated by the Indian contingent of UNIFIL. The bomb had previously been installed by the Israeli enemy and connected to a tree with a wire. Nobody was harmed.
	2000	From inside occupied territory, opposite the town of Aytarun, Israeli settlers directed a laser beam towards the Lebanese Army observation point.
17 October	0750	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0900 hours.
	0810	Inside occupied Lebanese territory opposite the town of Wazzani, the Israeli enemy continued with the engineering work that had begun on 15 October, installing 24 concrete T-wall units around its position in Humayri using a winch, a wheeled bulldozer, a Poclair excavator, a Bobcat vehicle, a roller, two trucks, a civilian pickup truck, seven labourers and eight guards. Work ended at 1600 hours, and all the soldiers and vehicles left in the direction of occupied territory.  At 1030 hours, while work was taking place, a UNIFIL topographical team approached the site from inside occupied territory, before leaving at 1600 hours.
	1030	An Israeli enemy patrol comprising two Hummer vehicles, one of which was equipped with a machine gun, approached from inside occupied Palestinian territory near Barad al-Tuffah, opposite Sahl al-Khiyam. A patrol member pointed the machine gun towards Lebanese territory. The patrol left in the direction of occupied territory at 1105 hours.
18 October	0800	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0850 hours.
	0900	Inside occupied Lebanese territory opposite the town of Wazzani, the Israeli enemy continued with the engineering work that had begun on 15 October. Gravel was spread on concrete blocks that had recently been installed, and in a trench that had been dug, with a view to completing the installation of concrete units around the position. For that purpose, the Israeli enemy used two trench diggers, a Bobcat vehicle, a wheeled digger and a civilian pickup truck. Work ended at 1640 hours.
	1130	A smoke bomb exploded while the civilian As'ad Hamdan was tending to his livestock near the withdrawal line at Jabal al-Saddanah, on the outskirts of the town of Shab'a, near observation point OP3 operated by the Indian contingent of UNIFIL. The bomb had previously been

		installed by the Israeli enemy and to a tree by means of a wire. Nobody was harmed.
20 October	0815	Inside occupied Lebanese territory opposite the town of Wazzani, the Israeli enemy continued with the engineering work that had begun on 15 October. Gravel was spread on concrete blocks that had recently been installed, and in a trench that had been dug, with a view to completing the installation of concrete units around the position. For that purpose, the Israeli enemy used two Bobcat vehicles, a trench digger, a wheeled bulldozer and a civilian pickup truck. Work ended at 1540 hours.
	1330	Ten motorcycles and two civilian cars approached from occupied Palestinian territory opposite Sahl al-Khiyam, near Barrad al-Tuffah. Fifteen soldiers in civilian clothing disembarked and took photographs of the Lebanese side. The patrol left in the direction of occupied territory at 1345 hours.
21 October	0750	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0820 hours.
22 October	0730	Inside occupied Lebanese territory opposite the town of Wazzani, the Israeli enemy continued with the engineering work that had begun on 15 October, installing 24 concrete T-wall units around its position in Humayri using a winch, a wheeled bulldozer, a Bobcat vehicle, two trucks, two civilian pickup trucks, a roller and six labourers. Work ended at 1520 hours, and all the soldiers and vehicles left in the direction of occupied territory.
	0745	Inside occupied Palestinian territory, opposite the town of Udaysah near point TP36, Israeli enemy soldiers trained a machine gun mounted on a Hummer vehicle towards Lebanese territory. The tank left in the direction of occupied territory at 0755 hours.
	0750	Inside occupied Palestinian territory, opposite the town of Udaysah near point TP37, Israeli enemy soldiers trained a machine gun mounted on a Hummer vehicle towards Lebanese territory. The tank left in the direction of occupied territory at 0810 hours.
	1030	A smoke bomb exploded while the civilian Mahir Hamdan was tending to his livestock near the withdrawal line at Jabal al-Saddanah, on the outskirts of the town of Shab'a, near observation point OP3 operated by the Indian contingent of UNIFIL. The bomb had previously been installed by the Israeli enemy and connected to a tree with a cable. Nobody was harmed.
	1800 1840	Six explosions were heard from within the occupied Shab'a Farms while helicopters circled over that area.
23 October	0750	A Hummer vehicle approached opposite the town of Udaysah near point TP36, inside occupied Palestinian territory. Israeli enemy soldiers trained a machine gun mounted on the vehicle towards Lebanese

		territory. The soldiers left in the direction of occupied territory at 0810 hours.
	0814	A 20-person Israeli enemy foot patrol crossed the withdrawal line at Bastrah, on the outskirts of Kafr Shuba town, near position 34-4 operated by the Indian contingent of UNIFIL. The patrol left in the direction of occupied territory at 0820 hours.
	0830	Inside occupied Lebanese territory opposite the town of Wazzani, the Israeli enemy continued with the engineering work that had begun on 15 October, installing 20 concrete T-wall units around its position in Humayri using a winch, two wheeled bulldozers, a Bobcat vehicle, two trucks, two civilian pickup trucks and a roller. The work ended at 1520 hours, and the patrol and vehicles left in the direction of occupied territory.
	1300 1340	At Birkat al-Naqqar, in the occupied Shab‘a Farms, the Israeli enemy marked the anniversary of the killing of Israeli soldiers in 2000. A force comprising three Defender vehicles, a Hummer vehicle, a white Rapid vehicle and a convoy transporting the soldiers’ families was in attendance. Thirty soldiers deployed in the surroundings.
24 October	0730	Inside occupied Palestinian territory, opposite the town of Udaysah, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0750 hours.
	0815	Inside occupied Lebanese territory opposite the town of Wazzani, the Israeli enemy continued with the engineering work that had begun on 15 October, installing 16 concrete T-wall units around its position in Humayri using a winch, two wheeled bulldozers, a Bobcat vehicle, two trucks, two civilian pickup trucks, a roller and six labourers. The work ended at 1730 hours, and the patrol and vehicles left in the direction of occupied territory.
25 October	0800	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0920 hours.
27 October	0830	Inside occupied Lebanese territory opposite the town of Wazzani, the Israeli enemy continued with the engineering work around its position in Humayri that had begun on 15 October. Gravel was spread on concrete blocks that had recently been installed. For that purpose, the Israeli enemy used a trench digger, a wheeled bulldozer, two civilian pickup trucks and five labourers. Work ended at 1700 hours.
	0950	While the UNIFIL liaison unit was carrying out reconnaissance for training purposes at Ra’s al-Naqqarah along with a Lebanese Army patrol, three Israeli enemy soldiers crossed the Blue Line by a distance of some 30 metres east of point B1. They left in the direction of occupied territory at 1005 hours.

	1040	In Ra's al-Naqurah, in occupied Lebanese territory, the Israeli enemy carried out the following hostile acts: <ul style="list-style-type: none"> <li>– At 1040 hours, two UNIFIL soldiers accompanied by two Israeli enemy soldiers conducted a reconnaissance round west of point M1.</li> <li>– At 1040 hours, a truck was used to deliver plastic pipes, which were laid behind the yellow gate (the border crossing gate) opposite point M1.</li> </ul>
30 October	0750	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0835 hours.
	0900	Inside occupied Lebanese territory opposite the town of Wazzani, the Israeli enemy continued with the engineering work that had begun on 15 October. Gravel was spread on concrete blocks that had recently been installed around the position in Humayri. For that purpose, the Israeli enemy used a trench digger, three trucks, two wheeled bulldozers, two civilian pickup trucks and three labourers. Work ended at 1330 hours.
	1450	While a Lebanese Army patrol was taking pictures at the Bastrah locality near the gate to the occupied Shab'a Farms, an Israeli enemy patrol consisting of two Hummer vehicles and four soldiers approached from occupied territory. The soldiers trained their weapons on the Lebanese patrol.
	1500	South of Kafr Shuba, Israeli enemy soldiers trained their weapons on two Lebanese Army soldiers. UNIFIL reports that, after the Lebanese soldiers had left, the enemy soldiers trained their weapons on an Observer Group Lebanon team.
31 October	0800	Inside occupied Palestinian territory, at the enemy Israeli position of Jabal al-Tayyarah opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0855 hours.
	0900	Inside occupied Lebanese territory opposite the town of Wazzani, the Israeli enemy continued with the engineering work that had begun on 15 October. Gravel was spread on concrete blocks that had previously been installed around the position in Humayri. For that purpose, the Israeli enemy used a Poclain excavator, a roller, a Bobcat vehicle, a truck, two civilian cars and four labourers. The work ended at 1530 hours, and the patrol and vehicles left in the direction of occupied territory.

12 October	1007	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 400 metres. The launch then left in the direction of occupied Palestinian territorial waters.
13 October	0655	Opposite Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for four minutes, proceeding on its way for some 50 metres.
