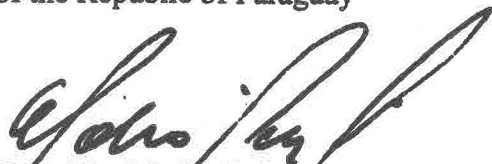
Excellency:

JOINT COMMUNIQUÉ  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN  
THE REPUBLIC OF MACEDONIA  
AND  
THE REPUBLIC OF PARAGUAY

The Republic of Macedonia and the Republic of Paraguay;

With the purpose to promote the spirit of mutual understanding and to strengthen the friendship and cooperation among their peoples;

Guided by the principles of the Charter of the United Nations and international law, particularly on international peace and security, equality among States, respect for national sovereignty, independence, territorial integrity, non- interference in the internal affairs of States and International Treaties

Have decided to establish diplomatic relations at Ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of the signing of this Joint Communiqué.

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in two originals, in English and Spanish, being all texts equally authentic.

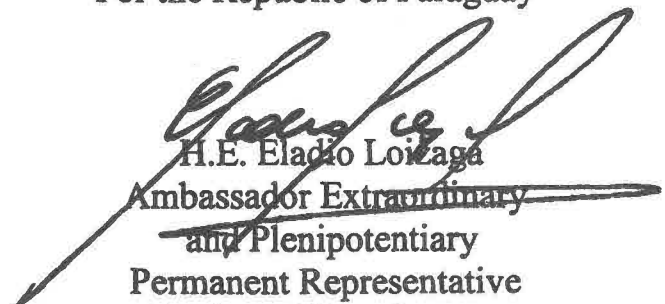

**La República del Paraguay y la República de Macedonia;**

Con el propósito de promover el entendimiento mutuo y de estrechar la amistad y cooperación entre ambos pueblos;

Sobre las bases de los principios y propósitos de la Carta de las Naciones Unidas y del derecho internacional, particularmente con respecto a la promoción de la paz internacional, la seguridad, la igualdad entre los Estados, la soberanía nacional, la independencia, los tratados internacionales, la integridad territorial y la no interferencia en los asuntos internos de los Estados;

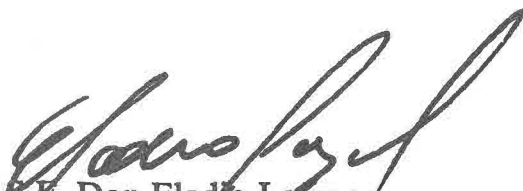
