Annotations

1. Election of officers

In accordance with rule 18 of the rules of procedure of the Economic and Social Council, each year, at the commencement of its first meeting, the Committee elects its Chair and four Vice-Chairs. In accordance with rule 19, Bureau members are eligible for re-election. One Vice-Chair is later designated to also serve as Rapporteur.

2. Adoption of the agenda and other organizational matters

In accordance with rule 13 of the rules of procedure of the Council, the Committee shall, at the beginning of each session, after the election of its officers, adopt the agenda for that session on the basis of the provisional agenda. The provisional agenda for the current session was approved by the Council in its decision 2017/276.

3. Applications for consultative status and requests for reclassification received from non-governmental organizations

(a) Applications for consultative status and requests for reclassification deferred from previous sessions of the Committee

The Committee will consider applications and requests for reclassification deferred from the sessions of previous years.

Documentation

Applications received from non-governmental organizations for consultative status with the Economic and Social Council deferred from previous sessions of the Committee held during the period 2008–2017 (E/C.2/2018/CRP.1) and requests for reclassification deferred from 2015–2017 (E/C.2/2018/CRP.2).

(b) New applications for consultative status and new requests for reclassification

The Committee will consider new applications for consultative status and new requests for reclassification from non-governmental organizations and will act thereon.

The Committee will consider deferred quadrennial reports (1998–2015) and quadrennial reports submitted for the 2013–2016 period.

8. General voluntary trust fund in support of the United Nations Non-Governmental Organizations Informal Regional Network

In its decision 2002/225, the Council established the general voluntary trust fund and requested the Non-Governmental Organizations Branch to identify and obtain the necessary financial, human and technical resources needed to carry out, in partnership with non-governmental organizations, Governments and other interested stakeholders, the development projects envisaged in the future framework of the United Nations Non-Governmental Organizations Informal Regional Network.

The Secretariat will report orally thereon.

In its resolution 1894 (LVII), the Council requested the Secretary-General to submit at each session of a subsidiary body of the Council a draft provisional agenda for its following session, together with information relating to documentation.
