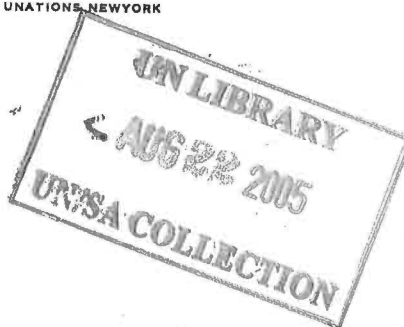



## SOLOMON ISLANDS MISSION TO THE UNITED NATIONS

New York, 2<sup>nd</sup> August 2005

Excellency,

I have the honour to inform you that the Government of the Solomon Islands has authorized me to notify the Government of the Federative Republic of Brazil, through Your Excellency, that, guided by our respective countries' shared willingness to develop ties of friendship and cooperation in the political, economic, cultural, humanitarian and other fields, the diplomatic relations between the two countries are henceforth considered as established at the Ambassadorial level by the Government of the Solomon Islands as of the date of this Note.

The Government of the Solomon Islands agrees that those relations will be founded on the principles and norms of the United Nations Charter and of International Law, as well as on the Vienna Convention on Diplomatic Relations of 18<sup>th</sup> April 1961.

This Note, together with Your Excellency's Note of the same day and content and which expresses identical decision on behalf of the Government of the Federative of Brazil, constitute the Agreement on the Establishment of Diplomatic Relations between the Solomon Islands and the Federative Republic of Brazil, and shall enter into force as from this date.

Please accept, Excellency, the assurances of my highest consideration.
