Decision No. 065/CENI/BUR/17 of 5 November 2017 on the publication of the presidential, legislative, provincial, urban, municipal and local electoral calendar

The Bureau,

Having regard to the Constitution of the Democratic Republic of the Congo of 18 February 2006, as presently amended, in particular article 211;

Having regard to Organic Act No. 13/012 of 19 April 2013 amending and supplementing Act No. 10/013 of 28 July 2010 on the organization and functioning of the National Independent Electoral Commission, in particular articles 9, points 1 and 5, 23 *novies* paragraph 2 and 24 *ter*;

Having regard to Act No. 06/006 of 9 March 2006 on the organization of presidential, legislative, provincial, urban, municipal and local elections, as amended by Act No. 11/003 of 25 June 2011 and Act No. 15/001 of 12 February 2015;

Having regard to National Assembly resolution No. 004/CAB/P/AN/AM/2013 of 7 June 2013 confirming the appointment of the members of the National Independent Electoral Commission;

Having regard to National Assembly resolutions No. 002/CAB/P/AN/AM/2015 of 9 November 2015 and No. 003/CAB/P/AN/AM/2015 of 26 November 2015 endorsing members of the Bureau, namely the President, Vice-President and Quaestor of the National Independent Electoral Commission;

Having regard to National Assembly resolution No. 02/CAB/P/AN/2017 of 15 June 2017 endorsing members of the Bureau, namely the Quaestor and Deputy Quaestor of the National Independent Electoral Commission;

Having regard to order No. 13/058 of 13 June 2013 on the investiture of the members of the National Independent Electoral Commission;

Having regard to order No. 15/083 of 16 November 2015 on the investiture of three members of the National Independent Electoral Commission;

Having regard to order No. 17/023 of 24 June 2017 on the investiture of two members of the National Independent Electoral Commission;

Having regard to the rules of procedure of the National Independent Electoral Commission, insofar as they have been declared consistent with the Constitution, in particular article 60 thereof, by the Supreme Court of Justice, acting as the Constitutional Court in its ruling R.CONST.267/TSR of 6 December 2013;

Considering chapter IV, paragraph 2, of the Comprehensive and Inclusive Political Agreement of the Inter-diocesan Centre of Kinshasa of 31 December 2016;

Considering the assessment meetings held in Kananga, from 28 to 31 August 2017 and in Kinshasa from 14 to 18 October 2017, respectively, between the Government, the National Council for Monitoring the Agreement and the Electoral Process and the National Independent Electoral Commission;

Having regard to necessity,

After debate and deliberation in the plenary assembly;

Hereby decides:

Article 1:

The organization is hereby ordered of presidential, legislative, provincial, urban, municipal and local elections, in accordance with the calendar attached hereto.

Article 2:

All previous provisions contrary to the present decision are hereby repealed.

Article 3:

The members of the Bureau, each within their area of competence, and the National Executive Secretary, are responsible for enforcing this decision, which shall enter into force on the date of its signature.
