
Excellency,

JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN
THE REPUBLIC OF CROATIA
AND
THE DEMOCRATIC REPUBLIC OF THE CONGO

The Government of the Republic of Croatia and the Government of the Democratic Republic of the Congo,

Desirous to strengthen the existing friendly relations and to develop co-operation in different areas of mutual interest, on the basis of mutual respect for the principles of sovereignty, territorial integrity and non-interference in the internal affairs of the other countries;

Guided by the principles and purposes of the Charter of the United Nations, as well as the Vienna Convention on Diplomatic Relations of 18 April 1961;

Have decided to establish, on the day of signing this Communiqué, diplomatic relations at the ambassadorial level.

Done in New York, on 19 October 2007, in duplicate, in the English, French and Croatian languages, all six texts being equally authentic.

Le Gouvernement de la République de Croatie, et le Gouvernement de la République Démocratique du Congo,


