We, therefore, kindly request Your Excellency to transmit this letter and the Joint Communiqué to all Member States of the United Nations for their information.



ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE  
DEMOCRATIC PEOPLE'S REPUBLIC OF KOREA AND THE KINGDOM OF  
SWAZILAND

The Government of the Democratic People's Republic of Korea and the Government of the Kingdom of Swaziland,

Willing to promote and reinforce friendly relations between the two countries and the two peoples, on the basis of equality, mutual respect for sovereignty, independence, territorial integrity and non-interference in the internal affairs of States,

Guided by the principles and purposes of the Charter of the United Nations and the Vienna Convention on Diplomatic Relations of April 18, 1961,

Have decided to establish diplomatic relations at ambassadorial level with effect from the date of signature of the present Joint Communiqué.

In witness thereof, the undersigned Plenipotentiaries, duly authorized by their respective Governments, have signed in duplicate this Joint Communiqué in Korean and English.


