We, therefore, kindly request Your Excellency that that the enclosed Joint Communiqué be circulated to all Member States as a document of the United Nations.



**JOINT COMMUNIQUE ON THE ESTABLISHMENT OF  
DIPLOMATIC RELATIONS BETWEEN  
THE DEMOCRATIC REPUBLIC OF TIMOR-LESTE  
AND  
THE GRAND-DUCHY OF LUXEMBOURG**

The Government of the Democratic Republic of Timor-Leste and the Government of the Grand-Duchy of Luxembourg, desirous of promoting relations of friendship and cooperation in conformity with the interest and desire of the two peoples, have decided to establish diplomatic relations between the two countries as of 27 September 2007, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961.

The two Governments have agreed to develop friendly relations and cooperation between the two countries on the basis of the principles and the objectives enshrined in the Charter of the United Nations and the norms of the International Law.

Done in New York, on 27 September 2007, in duplicate in English and French, both texts being equally authentic.

**COMMUNIQUE CONJOINT  
SUR L'ETABLISSEMENT DE RELATIONS DIPLOMATIQUES  
ENTRE  
LA REPUBLIQUE DEMOCRATIQUE DU TIMOR ORIENTAL

LE GRAND-DUCHE DE LUXEMBOURG**

Le Gouvernement de la République Démocratique du Timor Oriental et le Gouvernement du Grand-Duché de Luxembourg, désireux de promouvoir les relations d'amitié et de coopération conformément à l'intérêt et au désir des deux peuples, ont décidé d'établir des relations diplomatiques à compter de la date du 27 septembre 2007, conformément aux dispositions de la Convention de Vienne sur les relations diplomatiques du 18 avril 1961.

Les deux Gouvernements ont décidé de développer des relations d'amitié et de coopération entre les deux pays sur base des principes et des objectifs consacrés par la Charte des Nations Unies et les normes de droit international.
