## JOINT COMUNIQUE

### On Establishment of Diplomatic Relations between the Republic of Guatemala and Guinea Equatorial

The Republic of Guatemala and Guinea Equatorial, guided by mutual willingness to develop friendly and cooperative relations in the political, economic, humanitarian and other fields, have decided to establish diplomatic relations as of the date of the signing of this Joint Communiqué.

The two countries agree to establish their diplomatic relations in accordance with the Vienna Convention of 18 April 1961 on Diplomatic Relations and relevant principles and norms of the United Nations Charter and International Law.

The Republic of Guatemala and Guinea Ecuatorial, are fully convinced that the establishment of diplomatic relations corresponds to the interests of the two States and will further strengthen international peace and security.

Both countries agree to promote their bilateral dialogue at the Ambassadorial level through their diplomatic Missions to the United Nations in New York.

In witness whereof, the undersigned representatives, duly authorized by their respective governments, have signed this Joint Communiqué in four originals in English and Spanish, all text being equally authentic.

**COMUNICADO CONJUNTO SOBRE EL ESTABLECIMIENTO DE

La República de Guatemala y Guinea Ecuatorial, deseosos de desarrollar sus relaciones de amistad y cooperación en lo político, económico, humanitario y otros campos, han decidido establecer relaciones diplomáticas a partir de la fecha de firma del presente comunicado conjunto.

Los dos países convienen establecer las relaciones diplomáticas de acuerdo con las disposiciones de la Convención de Viena del 18 de abril de 1961 sobre Relaciones Diplomáticas y los principios y propósitos relevantes de la Carta de las Naciones Unidas y del Derecho Internacional.

Guinea Ecuatorial y la República de Guatemala están convencidos que el establecimiento de relaciones diplomáticas corresponde al interés de los dos Estados y fortalecerán la paz y la seguridad internacionales.

Ambos países han decidido promover su diálogo bilateral al nivel de Embajadores, a través de sus Misiones Diplomáticas acreditadas ante las Naciones Unidas en Nueva York.

En fe de lo cual los representantes que firman abajo, debidamente autorizados por sus respectivos Gobiernos, suscriben el presente Comunicado Conjunto en dos textos originales, en los idiomas español e inglés, haciendo ambos textos igualmente auténticos.
