**JOINT COMMUNIQUE ON THE ESTABLISHMENT OF DIPLOMATIC  
RELATIONS BETWEEN  
THE REPUBLIC OF GUATEMALA  
AND  
THE REPUBLIC OF THE GAMBIA**

The Government of the Republic of Guatemala and the Government of the Republic of the Gambia,

Guided by mutual willingness to develop friendly and cooperative relations in the political, economic, humanitarian and other fields, have decided to establish diplomatic relations as of the date of the signing of this Joint Communiqué.

The two countries agree to establish their diplomatic relations in accordance with the Vienna Convention of 18 April 1961 on Diplomatic Relations and relevant principles and norms of the United Nations Charter and International Law.

In witness whereof, the undersigned Ministers for Foreign Affairs, duly authorized by their respective Governments, have signed this Joint Communiqué in two originals in English and Spanish, all text being equally authentic.



El Gobierno de la República de Guatemala y el Gobierno de la República de Gambia;


