Excellency,



on establishment of diplomatic relations between the Republic of Macedonia and the Republic of Nauru

The Government of the Republic of Macedonia and the Government of the Republic of Nauru,

Willing to promote and reinforce friendly relations between the two countries and the two peoples, on the basis of equality, mutual respect for sovereignty, independence, territorial integrity and non-interference in the internal affairs of States,

Have decided to establish diplomatic relations at ambassadorial level with effect from the date of signature of the present Joint Communiqué.
