Excellency,

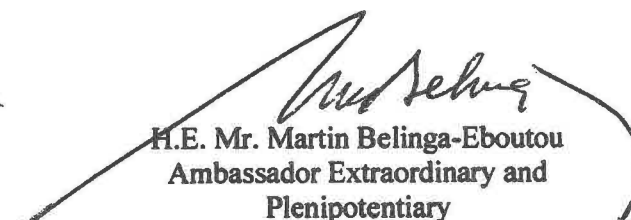

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
AT THE AMBASSADORIAL LEVEL BETWEEN
THE REPUBLIC OF ICELAND AND THE REPUBLIC OF CAMEROON**

The Government of the Government of the Republic of Iceland and the
Government of the Republic of Cameroon

Desirous:

1. to sustain and to strengthen the friendly relations between their two countries in the mutual interest of their peoples;
2. to promote and to intensify cooperation between their respective countries, in the political, economic, social and cultural domain;

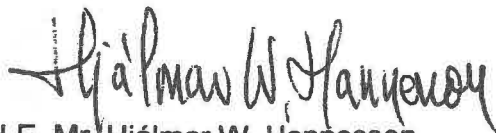
On the basis of their common adherence to the principles of international law, the goals and objectives of the United Nations Organization as regards to the need to preserve international peace and security, and to eliminate all forms of discrimination;

Decide to establish diplomatic relations between their two respective countries at the Ambassadorial level as of this day.

Désireux:
