The Brazilian Government agrees that those relations will be founded on the principles and norms of the United Nations Charter and of International Law, as well as on the Vienna Convention on Diplomatic Relations of 18<sup>th</sup> April 1961.

This Note, together with Your Excellency's Note of the same day and content and which expresses identical decision on behalf of the Government of the Republic of Nauru, constitute the Agreement on the Establishment of Diplomatic Relations between the Federative Republic of Brazil and the Republic of Nauru, and shall enter into force as from this date.
