JOINT COMMUNIQUÉ

On the Establishment of Diplomatic Relations between Austria and Palau

The Government of Austria
The Government of Palau

Desirous to develop and strengthen friendly relations and mutual understanding and cooperation among their two peoples, based on the purposes and principles of the Charter of the United Nations and the norms and principles of International Law,

Convinced that the establishment of diplomatic relations is in the interest of both countries and will contribute to international peace and security,

Have decided to establish diplomatic relations, at ambassadorial level, in accordance with the provisions of the Vienna Convention on Consular Relations of April 18 1961 and the Vienna Convention on Consular Relations of 24 April 1963, as of the date of the signing of this Joint Communiqué.
