In accordance with Executive Board decision 2011/11 and rule 11 of the rules of procedure of the Executive Board of UNICEF, the Board will elect a new Bureau consisting of a President and four Vice-Presidents. The President and Vice-Presidents of the Executive Board represent the regional groups of the United Nations Member States. In accordance with the rotation scheme established by the Board in its decision 1992/7, the President for 2020 will be nominated from among the Asia-Pacific States that are members of the Board. The election takes place on 14 January 2020.

The provisional agenda is prepared in consultation with the Bureau of the Executive Board and is based on the programme of work adopted by the Board at its second regular session of 2019. The Board will adopt the agenda for the session, making any amendments that it considers necessary.

In response to Executive Board decision 2019/9, revised and harmonized guidelines for the field visits of the Executive Boards of UNICEF; the United Nations Development Programme (UNDP), the United Nations Population Fund (UNFPA) and the United Nations Office for Project Services (UNOPS); and the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women), containing harmonized criteria for field visits, will be presented to the Board for information.
