Letter from the President of the General Assembly to the Chairman of the Fifth Committee

- 3. United Nations Joint Staff Pension Fund: annual report of the United Nations Joint Staff Pension Board
- 4. Report of the Negotiating Committee for Extra-Budgetary Funds
- 5. Scale of assessments for the apportionment of the expenses of the United Nations: report of the Committee on Contributions
- 6. System of travel and subsistence allowances to members of organs of the United Nations
