Changes in Geographical Distribution

Report of the Secretary-General

1. In its consideration of this subject at the eleventh session, the Fifth Committee proposed, and the General Assembly subsequently adopted, resolution 1097 (XI) which <u>inter alia</u> requested the Secretary-General to report to the twelfth session of the General Assembly on the changes which have occurred in the geographical distribution of the United Nations Secretariat staff during the year ending 31 August 1957.

2. The Secretary-General draws attention to the annex to the Annual Staff Listing $\frac{1}{}$ and believes that the greatest assistance will be given to the Fifth Committee by supplementing this information in the following form:

Table I - Appointments to Internationally Recruited Posts by Nationality (1 September 1956 - 31 August 1957)

This table lists in descending order of the number of appointments of each nationality, the 101 appointments which were made in the internationally recruited area between 1 September 1956 and 31 August 1957.

3. It will be seen that

(a) within the limits imposed by the number of vacancies to be filled by "outside" recruitment, it has been possible for the lOl appointments made to be spread among 39 nationalities;

(b) that emphasis has been directed, in accordance with the General Assembly resolution 1097 (XI), toward those nationalities which have formed a disproportionately small part of the Secretariat;

(c) that as in the previous year the majority of the new appointments have been made on a fixed-term basis.

4. The Secretary-General invites the Fifth Committee of the General Assembly to take note of this report.
