The Republic of the Marshall Islands and the Republic of Paraguay;

Convinced that the best way to strengthen international peace and security is through understanding, cooperation and friendly relations between nations;

Have decided to establish diplomatic relations, in accordance with the purposes and principles of the Charter of the United Nations and the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, from the date of signing of this Joint Communiqué.


In witness thereof, the undersigned Ministers of Foreign Affairs, duly authorized by their respective Governments, have signed this Joint Communiqué.
