PROVISION OF INFORMATION TO THE PEOPLES OF  
TRUST TERRITORIES

Letter dated 23 December 1949 from the Secretary-General of the  
New Zealand Delegation to the United Nations to the  
Secretary-General

I have the honour to refer to the subject of the provision of information to the people of the Trust Territory of Western Samoa and, in particular, to Resolution 36 (III) adopted by the Trusteeship Council on 8 July 1948, which invited members responsible for the administration of trust territories to furnish the Secretary-General with the names and addresses of officials in trust territories to whom should be sent for information records of the activities of the Trusteeship Council and other suitable material concerning the United Nations.

I have the honour to state that it is the practice of the New Zealand Delegation to transmit to the High Commissioner of Western Samoa for use in the territory copies of Trusteeship Council documents (including official records). In addition, from time to time the New Zealand Delegation has, in co-operation with the United Nations Department of Public Information, transmitted various information material (including posters, etc.) for use in Western Samoa.

I now have the honour to request, at the instance of the competent authorities, that twenty-five copies of the publications set out in the enclosed list and referred to in Annex A of document T/127 should be sent to the High Commissioner, Apia, Western Samoa. The High Commissioner will undertake the distribution of this material which it is proposed to allocate as follows:

The Resident Commissioner, Savai'i.  
Administration and Mission Schools.  
The Legislative Assembly.  
The Fono of Faipule,  
General Publicity.
