EXAMINATION OF PETITIONS

SOMALILAND UNDER ITALIAN ADMINISTRATION

Supplementary information from the Administering Authority

Note by the Secretariat: The following supplementary information, requested by the Trusteeship Council in connexion with petitions considered by the Council at its tenth session, was communicated to the Secretary-General on 15 May and 17 June 1952 by the Italian Observer to the United Nations. This information relates to the following petitions:

(1) PETITION FROM MR. ALI NUR ABDI (T/PET.11/36)

It has not yet been possible to reach a settlement of the above-mentioned case as some probatory documents concerning the two prisoners of Uardera and Galadi are missing.

In any case the Administrator is closely following the case and will not fail to solicit as prompt a decision as possible. Such decision, anyhow, can only be reached by the Italian Government as the issue antedates the war period.

(2) PETITION FROM CHIEF GIUMALE FARRE AND OTHERS (T/PET.11/58)

The Administration could not make an exception to the existing regulations, all the more so because other owners of sheds situated in the same locality of Bondere, having observed that Mr. Ahmed Ali Hassan was enlarging his shed without authorization, had expressed the intention of proceeding to do the same.

The complaints of the neighbours, brought to the attention of the Head of the Technical Office of the Mogadiscio Municipality, determined the decision taken by the Commune of that city with regard to Mr. Ahmed Ali Hassan.

We add that, as the Advisory Council had unofficially interested the Administration in the case under consideration in July, 1951, one of the officials of the Secretariat of the Council, Mr. Goro Deeb, was invited to approach the municipal authorities with the purpose of ascertaining on the spot the opportunity of the measure adopted with respect to Mr. Ahmed Ali Hassan. Mr. Deeb visited the place together with a representative of the Municipality of Mogadiscio and with the interested party, and verified the regularity of the measure adopted.

We enclose a French translation of the letter addressed to the Commissioner of the Municipality of Mogadiscio by the Head of the Technical Office of that city, together with copy of a letter addressed by Mr. Omar Mallim Ali to the Municipal Commissioner.^{1/}
