

## Report of Indonesia on the implementation of Security Council resolution 2397 (2017)

Indonesia reiterates its support for the implementation of Security Council resolution 2397 (2017), adopted on 22 December 2017, and the provisions related to nationals of the Democratic People's Republic of Korea earning income abroad with the intention of supporting the prohibited nuclear and ballistic missile programmes.

According to paragraph 8 of resolution 2397 (2017), the Council decided that Member States should repatriate to the Democratic People's Republic of Korea all nationals of that country earning income in that Member State's jurisdiction and all government safety oversight attachés from the Democratic People's Republic of Korea monitoring workers abroad from that country immediately but no later than 24 months from the date of adoption of the resolution, unless the Member State determined that a national of the Democratic People's Republic of Korea was a national of that Member State or a national whose repatriation was prohibited, subject to applicable national and international law, including international refugee law and international human rights law, and the United Nations Headquarters Agreement and the Convention on the Privileges and Immunities of the United Nations.

In fulfilling the obligation of Member States to submit a final report on the action taken pursuant to paragraph 8 of resolution 2397 (2017), which should be no later than 27 months from the date of adoption of the resolution, Indonesia has taken appropriate measures on the basis of its national regulations and processes.

As stated in the midterm report of Indonesia on the implementation of Security Council resolution 2397 (2017), submitted to the Committee on 2 April 2019, specifically paragraphs 4 and 5 on the underlying legislative and regulatory framework, as well as a comprehensive travel ban and strict visa issuance process, in 2018 and 2019 the Government of Indonesia issued a total of eight short-visit visas for nationals of the Democratic People's Republic of Korea to attend an international sporting event (the Asian Games) and/or United Nations-sponsored workshops or seminars. Apart from that, there are no other nationals of the Democratic People's Republic of Korea residing in Indonesia using work permits.

The Government of Indonesia will continue its efforts to implement relevant Security Council resolutions on the Democratic People's Republic of Korea, in accordance with its prevailing national laws and regulations.
