PROGRESS ACHIEVED BY THE NON-SELF-GOVERNING TERRITORIES
IN PURSUANCE OF CHAPTER XI OF THE CHARTER

Burma, Chile, Cuba, Ecuador, Egypt, El Salvador, Ethiopia, Guatemala, Liberia, Yugoslavia: draft resolution

The General Assembly,

Considering that Article 73 e of the Charter makes provision for the regular transmission to the Secretary-General of information on conditions in the Non-Self-Governing Territories whose peoples have not yet attained a full measure of self-government, and that resolution 218 (III), adopted on 3 November 1948, establishes a system for the transmission of such information and for the preparation of summaries of the information so transmitted.

Considering that by resolution 551 (VI), adopted on 7 December 1951, and by resolution 930 (X), adopted on 8 November 1955, the Standard Form for the guidance of Members in the preparation of the information has been adapted in the light of experience,

Noting that resolution 932 (X), adopted on 8 November 1955, suggests that an examination of the progress achieved in the Non-Self-Governing Territories since the establishment of the United Nations, based on the information received under Article 73 e of the Charter, would be highly desirable.

Considering that the principal points indicated by the Secretary-General in document A/3196 form a satisfactory basis for such a report,

l. Notes with appreciation the assistance provided to the Secretary-General in giving effect to resolution 952 (X) by the International Labour Organisation, the Food and Agriculture Organization of the United Nations, the World Health Organization and the United Nations Educational, Scientific and Cultural Organization;

- 2. <u>Invites</u> the Secretary-General, in collaboration with the specialized agencies concerned, to prepare for submission to the General Assembly at its fourteenth session a report on the progress that has taken place in the Non-Self-Governing Territories in accordance with the objectives set forth in Chapter XI of the Charter since the establishment of the United Nations;
- 3. <u>Invites</u> the specialized agencies concerned to assist the Secretary-General in the preparation of the report;
- 4. <u>Considers</u> that the report should be based on the information transmitted under Article 73 e of the Charter and on supplemental information supplied to the secretariats of the United Nations and the specialized agencies by the Administering Members concerned;
- 5. <u>Invites</u> the Administering Members to include in the information transmitted by them under Article 73 e of the Charter such information as may be necessary for the preparation of the report and in particular to provide a survey of the principles and practical measures showing general trends in the Territories concerned as requested in Section C of the Explanatory Preface of the Standard Form for guidance of Members in the preparation of information to be transmitted under Article 73 e of the Charter:
- 6. <u>Invites</u> the Secretary-General to keep the Committee on Information from Non-Self-Governing Territories regularly informed of the progress of the report provided for in this resolution.
