| 2 March | 0805 | From inside occupied Palestinian territory opposite the town of Ramiya, an Israeli enemy patrol pointed a Merkava tank cannon in the direction of Lebanese territory. The patrol left in the direction of occupied territory at 0845 hours. |
| | 0805 | From inside occupied Palestinian territory opposite the town of Ayta al-Sha'b, an enemy patrol pointed a Merkava tank cannon in the direction of Lebanese territory. The patrol left in the direction of occupied territory at 0845 hours. |
| | 0950 | Six civilian cars approached the Israeli enemy position of Jabal al-Tayyarah opposite Kafr Kila, in occupied Palestinian territory. Twenty-five individuals in civilian clothing stepped out, conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. |
| 3 March | 0830 | Opposite Ra's al-Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory west of point M2 along the Blue Line, in the area to which Lebanon maintains a claim. Civilians continued using a crane and a winch to weld metal netting to the beams that had previously installed. Work ended at 1730 hours. |
| | 1050 | At the locality of Ra's al-Naqurah, five Israeli enemy soldiers crossed the Blue Line by a distance of some 30 m between points M1 and B1, and conducted a reconnaissance patrol on top of the railway tunnel. At 1115 hours, the vehicle left in the direction of occupied Palestinian territory. |
| | 1420 | Near point TP36 opposite the town of Udaysah, inside occupied Palestinian territory, an Israeli enemy patrol trained a vehicle-mounted machine gun on Lebanese territory. The vehicle left in the direction of occupied territory at 1630 hours. |
