APPOINTMENTS TO FILL VACANCIES IN THE MEMBERSHIP OF
SUBSIDIARY ORGANS OF THE GENERAL ASSEMBLY

INTERNATIONAL CIVIL SERVICE COMMISSION

Note by the Secretary-General

1. By his note of 25 August 1976, 1/ the Secretary-General advised the General Assembly that the terms of office of five members of the International Civil Service Commission would expire on 31 December 1976 and that it would be necessary for the Assembly to appoint five persons to fill the resulting vacancies. The persons so appointed would serve for a period of four years, beginning on 1 January 1977.

2. Article 5 (1) of the statute of the Commission reads as follows:

"The members of the Commission shall be appointed for a term of four years and may be reappointed. Of the members initially appointed, however, the terms of five members shall expire at the end of three years, and the terms of five other members at the end of two years."

The members whose terms of office will expire on 31 December 1976, after having held office for a period of two years, are:

Mr. Amjad Ali	(Pakistan)
Mr. Michael O. Ani	(Nigeria)
Mr. A. S. Chistyakov	(Union of Soviet Socialist Republics)
Mr. P. N. Haksar	(India)
Mrs. Halima Warzazi	(Morocco)

3. Under the procedure set forth in article 4 of the statute of the Commission, the Secretary-General has carried out the prescribed consultations with Member States, with the executive heads of the other organizations and with staff representatives. He has also consulted with the Advisory Committee on Administrative and Budgetary Questions. As a result, the Secretary-General can advise the General Assembly that it was the unanimous view of all those with whom he has consulted that the members of the Commission whose terms of office will expire on 31 December 1976 should be reappointed by the General Assembly for full terms of office beginning on 1 January 1977.

4. Accordingly, the Secretary-General proposes that the Fifth Committee recommend to the General Assembly that it appoint the following persons as members of the International Civil Service Commission for terms of office of four years, beginning on 1 January 1977:
