APPOINTMENTS TO FILL VACANCIES IN THE MEMBERSHIP OF SUBSIDIARY ORGANS OF THE GENERAL ASSEMBLY

Investments Committee: confirmation of the appointments made by the Secretary-General

Note by the Secretary-General

- 1. At its present session, the General Assembly amended article 20 of the Regulations of the United Nations Joint Staff Pension Fund by the adoption by the Fifth Committee of draft resolution A/C.5/31/L.44, as amended, which provided for an increase from six to nine in the membership of the Investments Committee. The members whose terms continue beyond 31 December 1976 and the appointments and reappointments of the Secretary-General are set forth below. The consultations required by article 20 with the United Nations Joint Staff Pension Board and with the Advisory Committee on Administrative and Budgetary Questions, have taken place.
- 2. There are four present members of the Investments Committee whose terms continue beyond 31 December 1976: Mr. David Montagu and Mr. Yves Oltramare, whose terms expire 31 December 1977 and Mr. R. Manning Brown, Jr., and Mr. Jean Guyot, whose terms expire 31 December 1978.
- 3. The Secretary-General has appointed and requests confirmation of Mr. B. K. Nehru for a three-year term his present term expires 31 December 1976. He has also appointed and requests confirmation for three new members, namely, Mr. Aloysio de Andrade Faria and Mr. Stanislaw Raczkowski for three-year terms, and Mr. Toshio Shishido for a two-year term. The curricula vitae for the appointees being submitted for confirmation are attached as an annex to this document for the information of the General Assembly. In order to provide for a wider and more equitable geographic distribution in the membership of the Investments Committee the Secretary-General will submit a fourth new appointment to the General Assembly for confirmation either at this session of the General Assembly in an addendum to the present document or at the thirty-second session of the General Assembly. If the Secretary-General does not appoint a fourth new member at the present session he

will co-opt early in 1977 such a member to serve on an <u>ad hoc</u> basis with the Committee until he can seek the confirmation of that appointment by the General Assembly at its thirty-second session.

- 4. In order to provide for continuity in the membership of the Investments Committee, the terms of the members have been staggered. If the General Assembly confirms the proposed appointments, the United Nations Investments Committee would consist of the following members:
  - Mr. David Montagu and Mr. Yves Oltramare, whose terms of office would expire 31 December 1977,
  - Mr. R. Manning Brown, Jr., Mr. Jean Guyot and Mr. Toshio Shishido, whose terms of office would expire 31 December 1978,
  - Mr. Aloysio de Andrade Faria, Mr. B. K. Nehru and Mr. Stanislaw Raczkowski, whose terms of office would expire on 31 December 1979.
- 5. The advice of the Investments Committee has been of great value to the Secretary-General and his predecessors in carrying out their responsibilities for the investment of the assets of the United Nations Joint Staff Pension Fund. The Secretary-General very much appreciates their willingness to continue to carry on this important international public service. As the Secretary-General has stated to the Joint Staff Pension Board and the Advisory Committee, he draws in addition upon such specialized expertise as may be advisable, having in mind the investments of the Fund.
- 6. The Secretary-General also wishes to take this opportunity to pay special tribute to Mr. George Murphy who is retiring from the Committee. He has served as a member of the Committee since 1964 and as its Chairman since 1973. The Secretary-General and the Committee are greatly indebted to Mr. Murphy for the contribution he has made through his leadership, the depth of his judgement and the unstinting time and effort he has given to this work.
