SCHEDULE OF WORK OF THE FIFTH COMMITTEE AT THE ELEVENTH SESSION

Note by the Chairman

1. In order that the Fifth Committee may deal expeditiously with its heavy agenda, it is desirable that the Committee, at its opening meeting, agree on a tentative plan of work.
2. With that aim in mind, I am submitting below suggestions as to the schedule of work for the consideration of the Committee. This schedule takes into account the existing state of documentation, and reflects what appears to be a reasonable grouping of items. I will make certain further comments on the schedule at the opening meeting. The submission of this suggested schedule of work is not intended in any way to prejudice the views of the Committee as to the conduct of its business; but it is presented in order to facilitate the task of the Committee in determining the method in which it will schedule its work.
